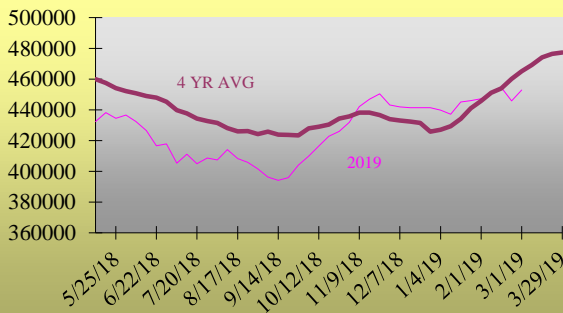

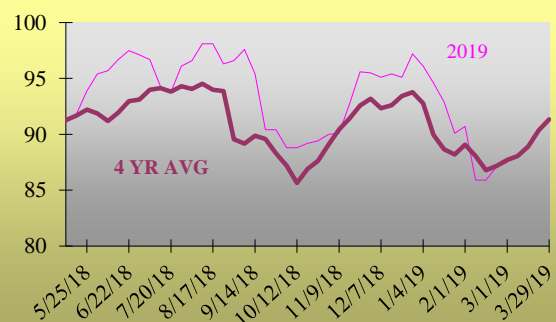

REFINERY PERCENT OPERATED



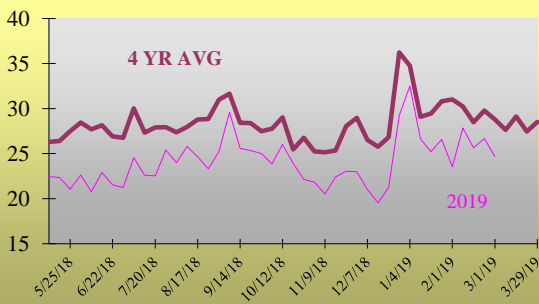

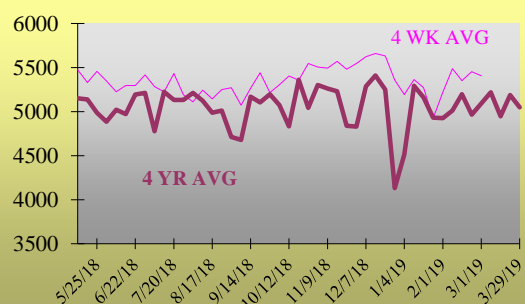

HEATING OIL DEMAND



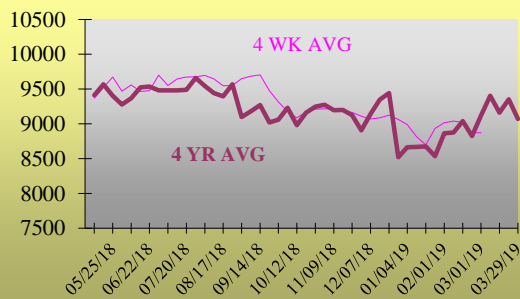

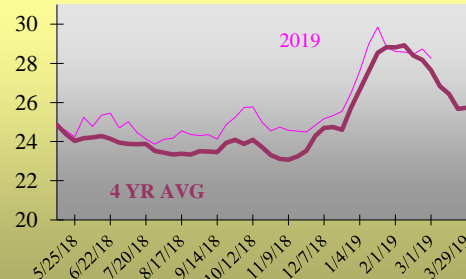
